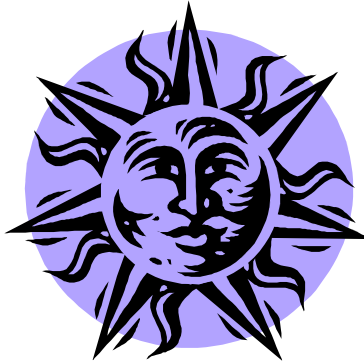


Finger Lakes Tibetan Spaniel Association
